New Zealand Reunion at the Bondi RSL: Vietnam Veterans Welcome Home March Sydney, 3 October 1987

On the 3 October 1987, I had the honour and privilege of being actively involved in the [cinemaphotography] production, that involved certain aspects of the Vietnam Veterans' Welcome Home March, Sydney. This film footage comprises: 3 hours of continual audio/visual colour 16mm cinemaphotography [now converted to DVD and Digital Betacam D321 Tape] which includes: the FUP: Domain, the march focusing on 4 RAR, and other units; with particular emphasis determined in capturing numerous personal and collective interviews of Vietnam Veterans, either on the Sydney Streets, or later at their respective reunion venues.

The last few chapters of this historical film depicts the NZ reunion venue at the Bondi RSL! Quite historical 20 -22 minutes of ceremonial footage, that includes the opening address in Maori, by a distinguished and eloquent Maori representative, followed by the Maori Hymn: 1, 2 & last verses; including the formal acceptance of a plaque and reef presented by the Cabramatta Vietnamese Community, followed by the presentation of a very special Maori carving on the stage venue [see attached snapshot6.jpg pic] Bondi RSL, which is described in Maori tradition, as a solemn and sacred thing [expressing the unity between Australia and New Zealand forces].


This film footage captures the audio address of some obviously very distinguished NZ Veterans, addressing the audience from the Bondi RSL dais, that continues for about 20 minutes; notwithstanding the preceding film footage that symbolically represents each of the 37 fallen NZ warrior's Vietnam War, by the march past of 37 memorial NZ flags; whilst the whole NZ contingent takes the salute at the Sydney Town Hall by Prime Minister Bob Hawke, accompanied by many other military personnel and political, church dignitaries!

I would appreciate wide distribution of these pictures for the purpose of identifying the gentlemen depicted on the dais of the Bondi RSL.

This film was produced by Sue Wild, with cinemaphotographer Preston Clothier, and Mark Arbict Director, and has only just recently been recovered from storage.




Willie Apiata VC - The Reluctant Hero

Due to overwhelming public interest in New Zealand's newest hero, the life story of Willie Apiata will now be told, including the incredible heroics which led to him being awarded the highest military honour.

On 10 November under strict embargo, Penguin Group (NZ) will release the much anticipated biography of New Zealand's newest hero, Willie Apiata, VC.



'I knew we had to move. With the wagon being on fire it could only protect us for so long. There were that many RPG rounds rocking it, hitting it one after the other ... sooner or later one of us was going to take a round if we stayed there.'

Lance Corporal Willie Apiata, a New Zealand Special Air Service trooper, was trapped at the front of a major fire-fight with suspected Taliban insurgents on a dark and desolate Afghan hilltop. One of his mates was bleeding to death and they were pinned down under intense enemy fire.

For Apiata there was no choice. He fell back on the values instilled in him by his mother, the skills learnt during a tough pig-hunting life in the bush on the East Coast of New Zealand, and the knowledge won from years of training with the NZSAS.

With the lives and safety of his mates his only priority, Apiata performed an act of courage that has now become part of New Zealand history – an act that saw him become the first recipient of the Victoria Cross for New Zealand and just the 14th holder of the Commonwealth's highest honour for bravery since the end of the Second World War.

From his early life in small town Te Kaha, to his actions in the deserts of Afghanistan, this is his story in his words. This is the story of Willie Apiata, VC.

An ordinary kiwi bloke, a very reluctant hero, just doing his job.

Chief of Army launches Devil's Own War

Historian John Crawford signs a copy of his latest book, the Devils Own War (OH-08-0787-07tn)

Family members of Brigadier General Herbert Hart, New Zealand Defence Force personnel, researchers, historians and other guests attended a special function to

launch *The Devil's Own War* edited by NZDF historian John Crawford at Defence House, on 11 November, Armistice Day.

The Devil's Own War contains the diary of Brigadier General Herbert Hart, which is now widely regarded to be one of the most important personal sources relating to the New Zealand Expeditionary Force.

The book, which was officially launched by the Chief of Army, Major General Lou Gardiner, includes gripping descriptions of both combat and life behind the front line during World War I.

Brigadier-General Herbert Hart left New Zealand in 1914 as a major in the main body of the New Zealand Expeditionary Force and returned in 1919 as a much decorated brigadier general. He commanded the Wellington Battalion during the closing stages of the Gallipoli campaign, and then served as a battalion and brigade commander on the Western Front between 1916 and 1918.

MAJGEN Gardiner said in his speech that, "like many soldiers, Hart had a dark sense of humour that helped him deal with the horrors that surrounded him. Hart, who was a keen cyclist, informed his much loved wife Minnie that he had been wounded at Gallipoli with a telegram that read: 'Double puncture; being vulcanised; well soon'."

For many years Hart's diaries have been one of the key sources used by New Zealand historians writing about the Great War. In the Wairarapa where Hart was born and lived, when he was not serving our country, his qualities have always been appreciated.

"The publication of *The Devil's Own War* will make his insights and experiences much more accessible to a wider audience, and will help New Zealanders appreciate what a significant figure he was," said MAJGEN Gardiner.

"The Defence Force is delighted to be contributing to this process by donating a copy of The Devil's Own War to every New Zealand secondary school.

"Herbert Hart was an outstanding military leader who always enjoyed the respect and trust of both his superior officers and the men he commanded.

Many of the attributes that made him one of New Zealand's greatest citizen soldiers are still relevant to the men and women of today's Defence Force. The values of courage, commitment, integrity and comradeship continue to be central tenants of our organisation.

"The Devil's Own War is a fine book and a fitting tribute to an exceptional New Zealander. I would like to congratulate John Crawford, our Defence Force Historian; Exisle Publishing; and all the other people involved in its production.

The book again brings home to us how much we all owe to the men and women who served our country in the First World War," MAJ GEN Gardiner said.

A number of Brigadier General Hart's descendants travelled from Northland and the Wairarapa to the launch. Hart's granddaughter, Merrilyn Bartram of Masterton, spoke of her special relationship with her grandfather who taught her to drive and to shoot.

The book launch was part of Coming Home Te Hokinga Mai, an official programme of government events to commemorate the 90th anniversary of Armistice Day.

Nov 08 - Navy on Parade in North Shore City

The North Shore City Council invited the Royal New Zealand Navy to exercise its Charter with North Shore City on Wednesday 5 November.

The Charter Parade is about granting

freedom of the city. It is a long standing custom stretching back to the time of the Middle Ages. It recognises, cements and fosters the close association North Shore City has with our naval ships and those who sail in them. It entitles the Navy the right and privilege of marching through the streets of North Shore City with drums beating, bands playing, colours flying, bayonets fixed and swords drawn.

The Charter Parade stepped off at 10:45 am in the vicinity of The Strand in Takapuna and featured a march past and salute to the Mayor of North Shore City, Andrew Williams. The parade comprised of a 50-man Guard of Honour, six 24-man platoons and the Band of the Royal New Zealand Navy.

Addresses to the public were provided by the Mayor of North Shore City and the Chief of Navy, Rear Admiral David Ledson.

Nov 08 - Navy's Survey Vessel assists Tongan Ferry





Hot on the heels of an earlier rescue mission involving

ing a 53ft yacht which ran aground on a reef outside Nuku'alofa in mid October, personnel from the Navy's hydrographic survey vessel, HMNZS RESOLUTION, again put their damage control skills to good use in making temporary repairs to another ship in distress. At 2:00 pm on Saturday 1 November RESOLUTION responded to a call for assistance from the merchant vessel Olovaha, a ferry used to maintain supply chains to the outer islands in the Kingdom of Tonga.

RESOLUTION was carrying out hydrographic survey work when its Commanding Officer answered a call for assistance from the vessel Olovaha which was taking on water as it headed from Vava'u to Nuku'alofa. Within an hour of hearing of the vessel's plight, a team of Navy personnel were aboard the Olovaha armed with construction materials to 'shore up' several gaping holes in the bow of the vessel.

RESOLUTION's Commanding Officer, Commander Murray Tuffin, and his ship's company of 49 men and women have been surveying in the South Pacific for the past six weeks with the task of updating navigational charts, some of which are dated as far back as 1898. Commander Tuffin says, "The methods and expertise applied to the problem onboard Olovaha were skills taught to all naval personnel and exercised regularly on all naval vessels. Refined over decades of experience of warfare damage and lessons learnt from other nations, the damage control skills are equally applicable and important for civilian vessels".

Barber and AHSO Joseph Shepherd onboard OLOVAHA (WN 08-0141-01).

After applying temporary patches to ensure that the vessel was in no danger, the Olovaha was farewelled to continue onto Nuku'alofa with its precious cargo of supplies and people. Meanwhile RESOLUTION will continue surveying in the Kingdom of Tonga before proceeding to Samoa and the Cook Islands destination of Pukapuka. RESOLUTION is programmed to return to New Zealand in mid-December after completing three months of survey work.

New training agreement to benefit Air Force pilots

Agreement that will foster training and exercise opportunities between New Zealand and Germany. (WN 08-0035-53tn)

Today's signing of a Status of Forces Agreement between New Zealand and Germany marks a significant step in the future relationship between the both nations' defence forces.

The agreement, signed by the Minister of Defence, Hon Phil Goff and German Ambassador to New Zealand, His Excellency Mr Jörg Zimmermann, sets out the conditions for the temporary stay of New Zealand Defence Force personnel in Germany for the purposes of all training, exercises and exchanges.

Chief of Air Force, Air Vice-Marshal Graham Lintott says the agreement is of particular significance for the Royal New Zealand Air Force (RNZAF) as it will cover the pilot exchange with Germany set to begin in early 2009.

"RNZAF pilots who will be operating the new NH90 helicopters will be among the first to benefit from this agreement.

"The arrival of the NH90 helicopter into the service will be an exciting milestone for the Air Force and working alongside other NH90 operators, such as Germany, will be of invaluable assistance in terms of training opportunities."

Initially, the RNZAF intends to send one pilot and one helicopter crewman for a 2 to 2 ½ year exchange to Germany in early 2009 and conversely will support German training programmes in respect of the NH90 in New Zealand.

Background Notes

The NH90 is an advanced medium utility helicopter, and will be used for frontline military and civil operations. It has the capability to support ground operations, counter terrorism, disaster relief, search and rescue and counter-drug operations.

Ten years in development, the NH90 represents current state of the art technology. It will be the cornerstone of the Defence Force capability over the next 30 years.

The total cost of the NH90s is \$771 million. More than a third of this cost includes logistics and support, comprising of spare parts, project costs, training, software and equipment, as well as currency hedging.

The RNZAF will introduce eight NH90 helicopters between 2010 and 2011 to replace its Iroquois fleet.

There are currently 855 New Zealand Defence Force personnel are deployed on 14 operations, UN missions and defence exercises around the world

Abandoned Ship Sparks Air Force Call Out

Changing Guard at the RSA

Today marks the end of an era when Mr Pat Herbert retires as Chief Executive of the Royal New Zealand Returned and Services' Association after 17 years of loyal and dedicated service - the second longest

tenure in the 92-year-old history of the organisation founded by Gallipoli veterans.

During Mr Herbert's tenure the RSA did not fade away but is today still one of the largest voluntary organisations in the country with over 200 RSAs and 125,000 members. Over the period there have been significant change in terms of the demographic of the membership with the passing of the last World War One veterans and demise of the World War Two veteran population, but largely offset with the growth of Service membership as well as Associate members, without military service, that now number over 60,000. Through this transitional period for the organisation Mr Herbert has strongly guided the RSA to the strong and respected position that it enjoys today.

"Pat Herbert has always dealt with issues as they arise, with a straight bat, a high sense of right and wrong, and in the same, even-tempered way," said the RSA National President Mr Robin Klitscher. "His great leadership skills and compassion have been applied at all levels throughout the organisation. All done with great humility which explains the very obvious regard in which he is held by everybody out there in the RSA community, the public service, and by politicians."

"Pat has been an exemplary advocate and representative of the RSA and we wish him some well-earned R&R in his retirement," said Mr Klitscher.

For Mr Herbert the greatest and most rewarding change has been the growing numbers of New Zealanders wishing to honour and remember our past and present servicemen and women as highlighted by the resurgence of interest in ANZAC Day and also Armistice Day, with the 90th anniversary of the latter taking place next month.

"To see so many families and young children attending Anzac Days and at the RSA afterwards is wonderful as our veterans deserve this recognition. There are so many great personalities and stories in the RSA which is what makes it such a wonderful organisation," said Mr Herbert.

Mr Herbert's successor, Dr Stephen Clarke, who takes up the position from tomorrow (1 November 2008), is no stranger to the RSA. Dr Clarke has been associated with the RSA from university days when his study of the observance of ANZAC Day was supported by the RSA. He returned from further overseas study in 1999 to take up the role as the Association's official historian and since 2001 has been based at RSA National Headquarters in many roles such as research officer, commemorations, web manager and most recently public relations.

"We welcome Dr Clarke into his new position in full appreciation that he will be taking up an appointment left vacant by a particularly well-respected and skilful Chief Executive, but confident also that he will discharge the duties entailed in an equally effective manner," said Mr Klitscher. "We know that Stephen brings with him an obvious and deep understanding of what we are all about."

A graduate from the University of Otago and the Australian Defence Force Academy, Dr Clarke has specialized in military history and is an expert on the history of the return of service personnel and war remembrance in New Zealand. He is a frequent consultant on film television as well as contributor to newspapers and books both here and overseas.

Over the last eight years at National Headquarters Dr Clarke has launched and managed the Association's website, poppy projections on Parliament and the Auckland War Memorial Museum, as well as the first mobile phone Poppy Appeal this past year. He was closely involved with the return of the Unknown Warrior in 2004 and has represented the RNZRSA in London for the dedication of the New Zealand Memorial in 2006 Memorial and in Turkey where he fulfilled a lifetime ambition to visit Gallipoli.

At 40, and married with a young family, Dr Clarke is the youngest permanent head of the RNZRSA since World War One. As the first Associate member to be appointed to this position, Dr Clarke is looking forward to assisting and guiding the RSA movement forward in the 21st Century.

"It is an exciting time to be involved with the RSA and the veteran community at a time when we enjoy such generous support from the community. The respect and connections we see each ANZAC Day is a reminder that veterans are treasured members of our society and that their stories is a part of our story as a nation," said Dr Clarke.

"I look forward to providing New Zealanders with new opportunities to connect and support the RSA, whether it be on ANZAC Day or Poppy Day, through our welfare and youth support programmes, or 'down at the Razza' itself."

From Kaitiāia to the Bluff Dr Clarke envisages the RSA will long continue to play an important role in local communities as it has done over the last century.

"There's plenty more history left in us yet," said the historian and new Chief Executive.
