As at July15th 2010, our current ASB shows a confirmed credit balance of \$11266.84.

I am holding a further \$450.00 in subscriptions & Q/Store sales. These monies have arrived today, 16 July 2010 and will be banked later after being processed.

#### Term Deposits

The Association's two Investment Accts:

72 Term Deposit \$22,550.00 3.75% matures 14/10/10 86 Term Deposit \$6,322.43 3.75% matured 13/05/10

I have yet to receive confirmation of the reinvestment amount.

- <u>72 Term Deposit of \$22500.00</u> earned \$1051.35 interest this past financial year. The interest was paid into our 00 Society cheque acct, the principal being reinvested.
- <u>86 Term Deposit</u> compounds and is reinvested.

As the interest rates are low at present, we should continue with 90-day Investments rates that are not much different from long-term rates.

- The June 2010 reconciliation I cannot complete until I receive a forwarded statement from National Secretary Hiro Hamilton who clears our association PO Box 90 Wairoa. Unfortunately, he is overseas at present, an oversight on our part.

**Important:** From 1<sup>st</sup> July 2009 until the 30<sup>th</sup> June 2010, all income is receipted and balanced to our Bank Statements.

During this period, we have only one discrepancy to report as follows:

Unfortunately, I was unable to match all receipts & records of sales to banking records, therefore these figures are not only based on what I could reconcile, but if it looked like the Q/Store then it was attributed to the Q/Store. However, there appeared to be considerably more cash banked than was receipted for the Q/Store & I believe that is significant in supporting the good work of our successive Quartermasters, volunteering much personal time and a lot of researching for providers & good deals.

### **Subscriptions 2010 – 2011**

#### **SELAMAT Subscriptions:**

Production costs 2009-2010 for SELAMAT were \$6492.15. This burden will be largely alleviated due to our new policy.

Last year 244 members received SELAMAT without paying either a donation or a subscription. Already many have paid the \$10.00 toward production costs.

Website delivery: costs a total of \$178.95 per annum.

The webmaster reported to me on 2/7/10 there were 201 people parked on the website, although we have un-parked approximately 60 members due to being un-financial.
